Announcement of the Graduate School, Chiang Mai University No. 45/2560 B.E.

Subject: Criteria and Operating Procedure for Thesis Publication (Issue No. 2)

According to the Regulation of Chiang Mai University on Graduate Education 2559 B.E., clause no. 29.6: a thesis work must be published or at least accepted to publish in a journal, media, printed matter, registered a petty patent or patent, or other ways of publication that are accepted in the field of study as specified by the graduate school, on each level and/or type of study. The Announcement of Graduate School no. 37/2559 dated 9th November 2559 B.E. has set the criteria of publication for all graduate programs which cause some programs unable to follow, thus frequently requiring special case exemption.

The Graduate School Executive Committee (GSEC) meeting no. 18/2560 on 27th October 2560 B.E., along with the recommendation of the University Executive Committee (UEC) meeting no. 2/2560 on 7th February 2560 B.E. and the recommendation of the University Academic Council (UAC) meeting no. 3/2560 on 14th March 2560 B.E. and meeting no. 12/2560 on 7th November 2560 B.E., the Announcement of Graduate School no. 37/2559 on Criteria and Operating Procedure for Publication of Thesis Work are revised and corrected as follows:

- 1. Clause no. 1 is abolished and replaced by the following statement
- "1. This announcement is effective for new open or new revision graduate programs from the academic year 2017."
 - 2. The following statement is appended to the clause no. 2.2 2)

"or full paper publication in an international conference proceedings accepted by the field of study."

- 3. Clause no. 2.3 is abolished and replaced by the following statement
 - "2.3 For doctoral degree:
- 1) Type 1.1: At least 2 dissertation work or a part of dissertation work must be published or at least accepted to publish in an international journal, and at least one of the two must be listed in ISI, Scopus, IEEE, PubMed or Web of Science database, and at least 1 dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.
- 2) Type 1.2: At least 2 dissertation work or a part of dissertation work must be published or at least accepted to publish in an international journal listed in ISI, Scopus, IEEE, PubMed or Web of Science database, and at least 1 dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.
- 3) Type 2.1: At least 1 dissertation work or a part of dissertation work must be published or at least accepted to publish in an international journal listed in ISI, Scopus, IEEE, PubMed or Web of Science database, and at least 1 dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

4) Type 2.2: At least 2 dissertation work or a part of dissertation work must be published or at least accepted to publish in an international journal, and at least one of the two must be listed in ISI, Scopus, IEEE, PubMed or Web of Science database, and at least 1 dissertation work or a part of dissertation work must be presented in an international conference accepted by the field of study.

In case of fine arts, visual arts or media arts, apart from the criteria for publication specified above, dissertation work may be published in the form and method accepted by the field of study, and must not be lower than the criteria set by the Ministry of Education, instead of publication in a journal or conference, by emphasizing on new knowledge or new concept creation which is an academic or professional innovation. The published work must be certified by internationally accepted artists or experts who are approved by the graduate school, and a publication in a journal listed in TCI Tier 1 or a presentation in an academic conference as specified in the curriculum."

- 4. The clause no. 2.4 is abolished and replaced by the following statement
- "2.4 At least one main publication of the thesis work must specify the student as the first author with the affiliation to specify at least "Graduate/PhD/Master's Degree Program in ... Faculty/College/School of ..., Chiang Mai University"."
 - 5. Clause no. 4 is appended as in the following statement
- "4. A program may specify additional criteria to that specified in this announcement, in terms of both level and number of publications.

In case a program is unable to comply with the criteria specified in this announcement, the program may specify in the curriculum the form, method, level and number of publications that are acceptable in the field of study, but not lower than the criteria specified by the Ministry of Education. The case must be proposed with reasons and necessities by passing through the Graduate Education Committee of Academic Sector (GECAS) and GSEC for additional remarks, then through the UEC, UAC and the University Council (UC) for approval."
